Line 158 was awarded to Individual Foodservice based on price and quantity they bid: QTY 10/1000 (ten cases of 1,000) for \$11.28. On July 24, 2019 vendor IFS stated that there was a type-o when filling in the quantity cell on the original Price Quote Sheet. It was supposed to read 10/100 (ten cases of 100), rather than 10/1000. This brings their unit cost to \$0.11; therefore they are no longer the lowest bidder.
